Dr. M. Meenakshi, Principal/ Chairman, Academic Council heartily extended a cordial welcome to the Hon'ble Secretary, Treasurer and all the members of the Academic Council present in offline and online and she requested Member Secretary, Academic Council / Dean (Academic) to present the agenda of the meeting.

Dr. K. N Anuradha, the Dean (Academics)/ Member Secretary of Academic Council welcomed the Hon'ble Secretary, Treasurer, Chairman of Academic Council, Mentor, members of the Academic Council and presented the overall agenda of approval, ratification, information and other issues for discussion.

A. Statutory Agenda:

21.01: To confirm the Minutes of 20th Academic Council Meeting held on 13th December, 2021.

The members were informed that, the minutes of meeting of 20th Academic Council was circulated to all the members on 27th January 2021 and requested the council for confirmation.

The members confirmed the minutes of the 20th Academic Council meeting held on 13th December, 2021.

21.02: To review the Action Taken Report (ATR) of the 20th Academic Council meeting held on 13^{the} December, 2021.

The members were informed that, the decision taken in 20th Academic Council meeting were implemented during the academic year 2021-2022.

The Council noted the information and confirmed the action taken report of 20^{th} Academic Council meeting.

B. Agenda for Discussion & Approval

*****, :

21.03: To approve: (i) Academic Regulations & Examination regulations (with effect from 2021-22) of UG Programme.

The Dean (Academics) presented the proposed Academic and Examination regulations (with effect from 2021-22) of UG Programme prepared as per the guidelines of VTU (Ref:VTU Circular: VTU/BGM/OS-Aca-Autonomy/2022-23/63 Dated 5th April 2022). While explaining the regulations she compared the new regulations (2021) with the regulations of 2018 viz. number of credits, attendance requirement, dropping of courses, withdrawal of courses, internship, types of Courses, passing standard of CIE & SEE (Theory, Lab & Theory integrated with Lab), New Grading system, Makeup examination, Supplementary semester, B.E. Minor degree, B.E. Honor degree, AICTE points, etc.

While discussing the regulations of B.E. Minor, Dean (A) informed the committee that as per new regulations a student can register for B.E. Minor degree with CGPA => 5 and requested the members permission to implement the same instead of CGPA => 8 which was approved in 20th Academic Council meeting. The members suggested to keep CGPA higher than the affiliated colleges and continue with CGPA => 8 for B.E. (Minor).

While discussing the Internship an industry expert Mr. Nagesh Puttaswamy expressed that Research Internship to be carried out by the students of 8th semester(as per 2021 scheme) is a wonderful thing and he opined that students from different streams of engineering should work together some live project within the campus along with industry people and few faculty from difference discipline and such a team of students can create a model and by working on it they can publish papers, patents and in turn this may lead to business model for the college itself and it gives lot of recognition to the Institute.

Further Dr. N. C. Shivaprakash, Mentor, appreciated the Dean's (Academics) efforts for summarizing & presenting the Academic regualtions.

During the discussion Hon'ble Secretary and Hon'ble treasurer PVPWT, suggested the Dean(Academic) to provide the necessary documents on the agenda of the Academic Council meeting well in advance to the members.

After the detailed discussion the Academic and examination regulations (2021-22) were approved.

21.04: To approve: Minutes of Meeting of BoS UG and PG Programme (2022-23) UG and PG Programme (M.Tech., MBA & MCA)
