## CENTRALIZED UPS FACILITY

- ❖ To minimize the difficulties in monitoring and maintenance of the decentralized UPS system, the centralized UPS system was established in the year 2019.
- ❖ This industry standard facility caters to the need of uninterrupted power supply to all the regular academic oriented laboratories, Data Center, and to the ministerial staff of the institute.
- ❖ This facility enables the institute to conduct on-line examinations both for college and others.
- ❖ Class room LED projectors are connected to this ups system to strengthening
- ❖ All computer laboratories connected with dedicated copper plate earthings.
- ❖ All out going circuits in the laboratories are connected with suitable rating MCB'S. And ELCB's are installed in the main distribution panel board.



## OUT COMES OF ENERGY AUDIT

- ❖ Proposed tariff change from industry (HT2A) to education institute implemented from July 2015, resulting approximate saving of Rs 12lakhs/pa in the energy bill.
- ❖ Proposed Solar installation work is ongoing. After completion, approximately 50% energy saving can be achieved, resulting saving of Rs 40-45 lakhs/pa.
- ❖ Implementation of proposed change from existing lamps to LED lamps is ongoing.
- ❖ Proposed timers for street lights implemented, and 50% of lights automatically switched off at 10.30pm and reaming lights is switched off at 60.00am, resulting approximate saving of Rs 2lakhs/pa.
- ❖ Centralized hot water facility implemented in the both hostels, resulted in approximate saving of Rs 10-15 lakhs/pa in the energy bill.
- ❖ Old panel boards/wiring replaced to reduce leakage current and hence energy saving.
- ❖ In the energy audit it was mentioned the no's of UPS installations should be reduced to reduce the charging current. Centralized UPS installed. Which results in energy saving.( The total 1500 no's of batteries connected to old ups systems, now only 80no's of batteries is connected to Centralized UPS)
- ❖ Proposed timers for exhaust fans has to be implemented.
- ❖ In the energy audit maintained separate inventory for lighting system, equipment, normal and abnormal thermal imaging of the load panels.

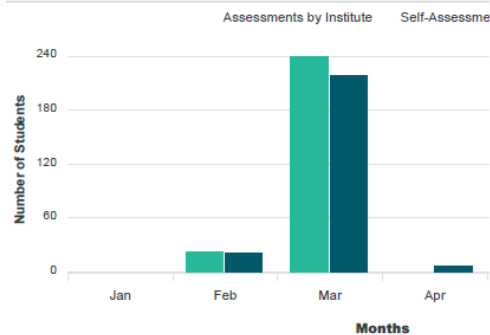

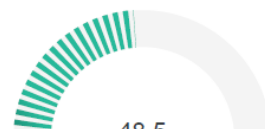
