Sri. S. Shivamallu pointed out that the procurement percentage is very low and informed the TEQIP Coordinator to place the order at the

earliest. The committee appreciated the result of TEQIP survey and suggested to put a benchmark of 65-70, as there is a lot of scope for improvement.

# Some of the observations made by the members on the Action Taken Report are as below:

- 1. Prof. N.C. Shivaprakash suggested to implement the SWAYAM platform (self study component) for atleast one subject in the 3<sup>rd</sup> semester to reduce the burden of the faculty should be reduced to improve the R&D activities. Sri. S. Shivamallu informed the members about the resolution made during the trust meeting to invite the retired professors exclusively for Research & Development activities in the college. The committee appreciated the trust for the decision taken for the development of R&D activities.
- 2. Dr. N.H. Siddalingaswamy gave the information on the AICTE new schemes i) Saansad Aadarsh Gram Yojana (SAGY) launched by Prime Minister of India, broadly focusing upon the development of the villages which include social development, cultural development and spread of motivation among the people on social mobilization of the village community. The students can register online and informed the Principal to give publicity among the students. ii) AICTE-ECI Chhatra Vishwakarma Award will be awarded for the best project irrespective of the department. The student can do any project using basic engineering skills. Students can apply online. These awards are to encourage truly successful efforts that have made a mark on the industry or the society in terms of delivering better outputs & processes and creating higher benchmarks for the industry / society to help in nation building.
- 3. Prof. K. Ramamurthy Naidu suggested that the meeting could start at 10.00 a.m. instead of 11.00 a.m. This was agreed.
- 4. The committee asked the Principal to present the vision, programme and innovative templates through PPT in the next G.B. Meeting. Only two departments can give presentation in each meeting.
- 5. Sri. S. Shivamallu instructed the Principal to submit a detailed report of improvement of slow learners (page 18) in the next meeting.
- 6. Sri. S. Shivamallu objected the condonation of attendance by the HODs mentioned in the minutes of Academic Council Meeting and as per the University regulation the authorised person to condone the attendance is the

Principal. As it may dilute the academic reforms, he instructed the Principal

to follow the University regulation scrupulously.

7. Sri. S. Shivamallu suggested to provide a list of the students who have scored

highest marks in the moderation process by external examiner, to check

whether the valuers corrected properly.

8. Sri. S. Shivamallu informed the committee about the international patent

accorded to a work by Dr. B.V. Sumangala and others entitled "A process

to extract liquid dielectric coolant from the Rice bran oil", carried out

in the Department of Electrical and Electronics Engineering. The committee

has appreciated the achievement.

The Chairman thanked the members for fruitful and enlightened discussion.

He said that after every meeting, follow up action plays a major role. Unless

there is special unit which constantly reviews the developments, there is no

effective use of discussion. He informed the Principal to form a small unit of

professors to follow up the developments.
