All correspondence related to the scheme must contain this number along with year of sanction of the scheme; failing which correspondence will not be entertained

- d) The University/Institution is expected to submit the above said mandatory documents viz. Utilization certificate, Expenditure Statement and completion certificate etc. within one month of completion of SPDP Scheme. However, delay of further 2 months may be condoned by AICTE in special circumstances as explained by the institute.
