

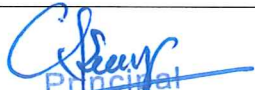

The Chairman welcomed all the members of BOG for the meeting and requested the Principal to continue with the agenda. The Co-ordinator, TEQIP-III Dr. Mahalinga V Mandi, Co-ordinator sought for the confirmation of the proceedings of previous meeting held on 16.03.2019.

A report on department-wise faculty internship, action plan of Industry Institute Interaction, MoUs with Industries, establishment of multidisciplinary labs and patent filed and granted and Equity Action Plan (EAP) were submitted to the members.

A report on TEQIP-III activities held from April 2017 to December 2018 was also submitted to the members of BOG.

While discussing the action taken report Shri. S Shivamallu, member suggested to form a committee for selecting of faculty and staff for deputation to FDP/SDP in future as there is considerable amount is involved in academic activities. In reply to this Dr. M Mahadeva, Member stated that there is no

necessity of forming a separate committee as the Managing Trustee/Secretary and the Principal are approving such deputations after examining in detail. The Chairman agreed with and opined that the existing procedure can continue.

Dr. M Mahadeva, Member expressed his displeasure at the low number of GATE students qualified. In reply the Principal briefed on the action planned taken for the forthcoming year like organizing the training classes by inviting Gate Qualified Research Scholars from IISc and other reputed training Institutions along with our faculty and to motivate the students to take up the GATE examination and to qualify.

With the above deliberations, the minutes of the meeting held on 16.03.2019 was read and confirmed.

After the confirmation of the minutes of the previous BoG meeting, the members took up the agenda for discussion.

#### **AGENDA-1**

##### **1.3.1 Procurement of Goods:**

The members insisted that the expenditure on project lifetime allocation (PLA) should be fulfilled by September, 2019 as suggested by the NPIU. While discussing the procurement activities the Nodal officer, procurement sought the approval of BOG to make payment for internet connection from IOC. In this connection the BOG asked him to take prior approval from NPIU before payment from IOC.

During the discussion the Chairman suggested to enquire from reputed book distributors like, Sapna Book House, Higgins & Botham etc., as to the discount they allow on declared price of books and procure of Books from the sellers who gives best rebate instead of advertisement in newspapers.
