With reference to above subject and reference, the HoDs of UG are hereby informed to note the following,

1. The Supplementary/Fast-track Semester will be conducted as a one-time measure for **students of 3rd year B.E.** admitted in the year 2021-22(Regular) and 2022-23(Lateral entry) after their 6th semester.
2. The Supplementary/Fast-track Semester will take place from **19th August to 17th September 2024.**
3. Students of 3rd year B.E. can register for a maximum of **16 credits** during this Supplementary/Fast-track Semester.
4. Registration for the Supplementary/Fast-track Semester will commence on **7th August 2024** and will close on **12th August 2024.**
5. Students must fill out the registration form with the course titles, Course codes and payment details. The completed registration form, along with the payment receipt, should be submitted to the Dean (Academic) office by **12th August 2024.** Additionally, the registration forms must be forwarded through the concerned Head of Department and Mentor.

Note: Registration fee: Rs 1,100/- per credit.

Preamble:


Several Autonomous colleges have requested permission to conduct supplementary semester / fast-track semester for students admitted in 2021-22 after their 6th semester and brought to the notice of the University that this facility will allow these students to become eligible for the 7th semester and increase their opportunities for placement. The university has also received aforesaid requests from students of these colleges. Hence, a committee was constituted to study the matter and report to the University. Accordingly, the Committee met and submitted its recommendations to the University. The recommendations were placed before the Executive Council of the University and as approval of Executive Council the following is notified.

Year of admission	Revised Rules
2021-22	The Supplementary Semester or fast-track semester is permitted for 2021-22 batch admitted students after their 6 th semester as a one-time measure. The maximum number of credits permitted for registration in this supplementary semester shall be 16.

In a few cases, it has been observed and noted by the University that affiliated-autonomous colleges have not followed / advised the students about the existing and amended regulations issued from time to time. Hence, the Principals of affiliated autonomous colleges shall note all the existing regulations applicable to different schemes and advise the students accordingly. Any deviation of the regulations shall be viewed seriously by the University.

The content of this notification shall be brought to the notice of the concerned.
